

Board of Directors, Special Meeting Minutes, Tuesday, July 11, 2023 RICHLAND SCHOOL DISTRICT NO. 400 BENTON COUNTY, RICHLAND, WASHINGTON

The Board of Directors of Richland School District No. 400 met for a special meeting Tuesday, July 11, 2023, at 5:00 P.M. via Zoom and in person, 6972 Keene Road, West Richland, Washington. School Board President Kari Williams presided. Board members participating: Jill Oldson, Semi Bird, Audra Byrd, and Rick Jansons. Administrators present: Superintendent Dr. Shelley Redinger, Executive Director of Operations Richard Krasner, and District Counsel Galt Pettett.

The Special Board meeting was called to order at 5:02 P.M.

2.0 COMMUNICATIONS

2.1 Requests and Comments by Visitors (2 minutes per individual)

Zoe Smith, Richland, stated she is a former graduate of Richland Schools and shared her concern regarding the Appeal on tonight's agenda. She stated all students need to be loved and doesn't feel the curriculum in the Appeal needs to be removed.

Jane Schmoetzer, Richland, advised many students in the District have beliefs contrary to her beliefs, but she wants children to be strong and critical thinkers. She asked the Board not to remove the material mentioned in the Appeal.

Darcy Brightman, West Richland, feels that hateful public comments at Board meetings should be shut down and does not feel the material in the Appeal should be challenged.

Mae Bolling, West Richland, stated she is a recent graduate of Richland Schools and feels compassion for all students is needed. She asked to shut down the Appeal request.

Lorrie Reid, Richland, has been a Para in the District for 19 years and shared concern that raises are only given on base pay. Ms. Reid stated only 150 Paras have been in the District for more than five years.

Shelly Burt, West Richland, shared the District has a policy regarding controversial issues and parents should be given the opportunity to opt out of certain materials.

3.0 NEW BUSINESS

3.1 Instructional Materials Committee Appeal (per Policy No. 2020-Course Design, Selection, and Adoption of Instructional Materials)

Mr. Pettett, General Counsel, reviewed the appeal process (per Policy No. 2020) which allows parents to submit Appeals to the Principal, the Instructional Materials Committee (IMC), the Superintendent, then the Board of Directors (within 30 days of the Superintendent's response).

Mr. Bird asked Mr. Pettett to summarize the appeal. Mr. Pettett shared the complaint form regarding supplemental materials from Ms. Burt, read the Principal and the IMC decisions, and stated timelines were met by all parties. Mr. Pettett stated the Superintendent upheld the decision by the IMC. Board discussion followed.

It was moved by Mr. Jansons and seconded by Ms. Oldson that –

THAT THE BOARD OF DIRECTORS UPHOLD THE DECISION OF THE SUPERINTENDENT AND INSTRUCTIONAL MATERIALS COMMITTEE.

Further discussion followed.
